ANNUAL REGISTRATION SCHEME (ARS) 2016-17

Dear Member,

We are pleased to inform you that the Managing Committee of Bhilai Branch of CIRC of ICAI has decided to start **Annual Registration Scheme (ARS)** for the year 2016-2017 towards all CPE programmes to be organized by Bhilai Branch.

This scheme is beneficial for both the branch as well as the members. For the Members, it will result in considerable savings and moreover our members will be freed from the inconvenience of Individual registration for each and every programme.

The mandatory CPE Credit requirement for the rolling periods of three years started from the calendar year 2016 is given below:

All the members who are holding Certificate of Practice (except those members who are residing abroad), unless exempted, are required to:

- Complete at least **90 CPE credit hours** in each rolling three year period of which 60 CPE credit hours should be structured learning.
- Complete minimum **20 CPE Credit hours** of structured learning in each year.

All the members who are not holding Certificate of Practice or residing abroad (whether holding Certificate of Practice or not), unless exempted, are required to:

- Complete at least **45 CPE credit hours** of structured / unstructured learning in each rolling three year period.
- Complete minimum **10 CPE credit hours** of structured/ unstructured learning in each year.

To cope with the new challenges in the profession, we conduct number of seminars and meetings considering the suggestions received from honorable members apart from the regular Seminars / Study Circle meetings on Direct Tax, Indirect Tax, Company Law, Accounting Standards, Auditing, etc.

Please note that the scheme will not cover programmes organized jointly with other Branches / Regional Councils / Central Council and Residential Courses. The rate for ARS is applicable for the period commencing from **01st April 2016 to 31st March 2017**. The CPE Credit will be awarded to members on the basis of physical attendance of the member in the CPE programme.

We request you to return the attached Registration Form duly filled and signed along with a Cheque/DD drawn in favour of "**Bhilai Branch of CIRC of ICAI**" for **INR 4500/- (FCA Members)** or **INR 3500/- (ACA Members)**.
